Guangzhe Chen, Vice-President, Infrastructure, World Bank

Guangzhe Chen, a seasoned Chinese economist, currently serves as the Vice President for Infrastructure at the World Bank, assuming the role on February 1, 2023. In this capacity, he spearheads the World Bank's global initiatives focused on establishing sustainable infrastructure in developing and emerging economies. His leadership

extends to critical areas such as energy, transport, and digital development, emphasizing public-private partnerships to facilitate access to renewable energy, low-carbon transportation, and quality infrastructure services. Notably, he previously served as the Regional Director for Infrastructure in the South Asia Region, overseeing projects totaling approximately \$17 billion across Afghanistan, Bangladesh, Bhutan, India, Maldives, Nepal, Pakistan, and Sri Lanka.

Mr. Chen boasts a distinguished career with the World Bank, having held pivotal roles such as the Global Director for Transport Global Practice and the Country Director for Ethiopia, among others. His expertise spans over 25 years, with a focus on sustainable development, infrastructure finance, and management. A Harvard University graduate in Economics, Mr. Chen holds a rich academic background, complemented by his Bachelor of Arts in Economics from Zhongshan (Sun Yat-Sen) University, Guangzhou, China.

Dolf Gielen is the lead for the Green Hydrogen Program in ESMAP. Prior to joining the World Bank, Dolf worked for IEA, IRENA, and UNIDO. He has 30 years of experience in energy and climate policy, with an emphasis on innovation, technology, and economics. Dolf has advised

many senior public and private sector players in various settings. This includes CEM, G7, G20, MI, SE4ALL, UNFCCC, SE4ALL and WEF, amongst others. He was part of the management team that established IRENA as a new intergovernmental agency.

Dolf has a PhD from Delft University of Technology in the Netherlands in energy and materials systems modeling. He studied chemical engineering and environmental sciences. Dolf has written more than 150 peer-reviewed scientific papers, books, and reports. At the center of his work is the support for better-informed energy and climate decision-making.

In September 2023, when Daryl Wilson, the Executive Director, stepped down for health reasons, Steven was appointed as the Interim Executive Director, to guide the Council during this transition. Steven has an industrial track record with various roles in R&D, industrial scaling up processes, marketing, and sales, as well as general management. Since 2000, he has been specializing in stakeholder engagement processes applied to strategy and innovation, across a range of sector and themes. He holds a PhD in physics.



Jo Tyndall, Director for the Environment Directorate, OECD

Since 15 September 2022, Jo Tyndall is Director of, the Environment Directorate at the OECD where she oversees the implementation of the Directorate's program of work, covering a broad range of environmental issues, including green growth; climate change; biodiversity; quality of

ecosystems; eco-innovation; circular economy; and resource productivity. Jo Tyndall was New Zealand High Commissioner (Ambassador) to Singapore from February 2019 to September 2022. From 2016 to December 2018, she also co-chaired the United Nations Framework Convention on Climate Change's (UNFCCC) Ad Hoc Working Group on the Paris Agreement (APA). As Climate Change Ambassador, she was head of the











delegation to the United Nations climate negotiations with the Ministry of Foreign Affairs and Trade.

Since September 1, 2023, Astrid Manroth has officially joined as the new head of the G20 Global Infrastructure Facility (GIF), based in Washington DC. Astrid has 25 years of experience in development finance, specializing in infrastructure and climate finance in the public and private




Don Purka, Principal Investment Officer, IFC
