To inform the design and implementation of energy subsidy reforms that aim to reduce fiscal stress and improve sector performance while providing incentives for greater energy efficiency and increasing the use of renewable energy. And finally, to pre sent recent country experiences, research and analytical tools to help practitioners design and implement sustainable energy subsidy reforms.

In this event, we will consider energy subsidies for fossil fuels and electricity, but not subsidies for renewable energy. Discussions at the KEF will be structured in 6 sessions spanning two days. International Geneva, Green and Sustainable City Tour

For more than 30 years, the City of Geneva has been pursuing a proactive energy policy. This policy has continuously evolved over time. Today, the City of Geneva is committed to follow a strategy of "100% renewable energy and zero emission of CO_2 by 2050," Its investments in district heating and cooling, rational management of electricity and water, public lighting, mobility and climate, make Geneva one of Switzerland's top-performing cities. Indeed, Geneva has been awarded the Gold Label for Energy Cities in 2010 for the successful implementation of its sustainable energy policy.

The walking tour will start at the lakeside and lead visitors through Geneva's international district, stopping at Maison de la Paix, International Museum of the Red Cross and Red Crescent, as well as Place des Nations, presenting innovative solutions in terms of sustainability. Visitors will learn about the hydrothermal system GeniLac[®], a 100% renewable thermal solution, making use of lake water to provide heating and cooling capacity for residential and commercial buildings in the international district.

IS THERE AN APP THAT WILL HELP ME GET AROUND DURING MY STAY IN GENEVA?

GVApp saves you time as soon as you land, giving you in real-time the schedules of the next buses and trains departing from the airport. Our application also guides you among all the other transportation means that are available upon arrival (taxis, shuttles to hotels, rental cars). Find shopping, money exchange places, lounges, arrival and departures, etc.

The app also helps you get around the airport.



IS THERE FREE WI-FI AT GENÈVE AÉROPORT?

Yes, Genève Aéroport offers 120 minutes of free Wi-Fi to its passengers and visitors. The various connection options are explained in the <u>GVA Free Wi-Fi description sheet</u>.

HOW CAN I CONNECT TO WI-FI IF I CAN'T USE AN SMS SERVICE?

You have two options if you do not wish or are unable to use an SMS service:

- 1. Scan the Boarding Pass to get an access code. Five access points are available in the terminal.
- 2. Get an access code on presentation of an identity document at the Visitor's Centre (Arrivals level)

CAN I LEAVE BAGS IN THE LEFT LUGGAGE?

Yes, you can deposit your bags either in lockers or at a counter (e.g., for bulky items). The lockers and counter are located on the Swiss Railways airport station.

HOW FAR IS THE CITY CENTER FROM THE AIRPORT?

Train departures are every 12 to 20 minutes from the Geneva Airport to Gare Cornavin Central Railway Station (and vice versa). One way takes 6 minutes. From Gare Cornavin, you can catch a bus/tram practically anywhere. First train from Geneva to GVA Airport goes at 4:43 am and the last one at 0:07.



TRAVEL FREE ON PUBLIC TRANSPORTATION ON ARRIVAL AT THE AIRPORT

TRAVEL FOR FREE ON PUBLIC TRANSPORT FREE TICKET ON ARRIVAL AT THE AIRPORT | You can pick up a free ticket for public transportation from the machine in the baggage collection area at the Arrival level. This Unireso ticket, offered by Genève Aéroport, allows you to use public transport in Geneva free for a period of 80 minutes.



Take Tram 15 and get off at Móle in the direction of "Palettes-Acacia-Gare Cornavin." This tram will stop directly in front of the hotel, see image.

RIDE FOR FREE DURING YOUR STAY IN GENEVA | You will receive a "<u>Geneva Transport Card</u>" free of charge upon check-in at the Hotel Royal. With this personal card, public transport in Geneva is free for the full duration of your stay. Info: <u>www.geneva-tourism.ch</u>

ENERGY SUBSIDY REFORM ASSESSMENT FRAMEWORK (ESRAF)

Reforming subsidies can be a complex and politically unpopular process. Countries that have embarked on this journey underline the need for understanding the political context of reform, crafting the right energy pricing, designing solutions that mitigate the adverse impacts of reform on affected populations, and engaging with citizens.

Energy Subsidy Reform Assessment Framework (ESRAF) is a comprehensive analytical toolkit and assessment framework for helping countries to identify and quantify energy subsidies, understand their impact, and evaluate the enabling environment for reform.

ESMAP offers detailed explanations on how governments can identify and quantify their energy subsidies, analyze their impacts on households, industry, the economy and the environment. The notes outline the main issues, present essential diagnostic tools, and provide guidance on how to conduct relevant analysis at country level. They also contain specific country experiences from across the world.
