

- → Reaches more than 568 academic facilities from 66 municipalities, 98% of this facilities are located in low income brackets 1 and 2; 2.342 teachers trained, 287.000 students benefitted.
- Supported in 2011 419 small businesses that generate 838 jobs and benefit more than
   2.933 persons.


#### **Natural Gas Distribution Business**

- Through 5 LDC's Promigas serves 20% of Colombia's population which represents 40% of the market.
- Out of 6 million current users, 80% belongs to low income families.
- Currently there are still 624,583 households to be connected, from which 97% belong to income brackets 1 and 2 (605,846 households).
- Main barrier: Connection cost.

#### Crossed Subsidy Scheme:

Government established a consumption subsidy to make natural gas affordable for low income households.

#### **Connection Fees financing:**

Breaking the barrier for low income families

→ How can low income families (5-7 members) with an AVG monthly income of less than US\$332 afford connection fees to gas services?

#### Financing alternative provided by LDC's:

• Term : up to 72 months

Down payment : US\$19

•Average Payment / Mo. : US\$10 - US\$13

• AVG Collection : 98%

- 98% of the customers use this alternative!
- However, cost connection is still a strong barrier for very low income families specially in small municipalities



## Profitable infrastructure with high social impact

#### **Natural Gas Distribution Business**

➢ In 2011, more than 6 million households in the country benefitted with natural gas service, which represents 55% of Colombia`s overall population.

## Colombian Natural Gas Project - PPP

### 1st Experience managing donated funds

- The Netherlands began looking for projects focused on protecting the planet and improving people's life quality.
- Promigas presented the "Natural Gas Distribution Project PPP" competing among other 5,000 projects in the world. Only two projects were approved in Colombia.
- Dutch Embassy donated 1 million Euros to the Colombian Caribbean coast.
- Project started in 2005 and ended in 2008.

#### Project's Objectives




- Subsidize natural gas service connection to 10,003 families in low income brackets 1 and 2 in 13 Caribbean coast's towns (without natural gas service).
- Contribute to region's development and improve families' life quality through natural gas service and social development programs.
- Aware communities on the benefits of using natural gas.



## Colombian Natural Gas Project - PPP

## 1st Experience managing donated funds

Operational Outputs



- Funds were invested in Col pesos in a financial institution. Returns made it possible for 716 additional subsidies.
- Funds were administered by Fundación Promigas.
- Connection Cost 2005(average) US\$370.
- Subsidy per household 2005 US\$141.
- Percentage subsidized 38%.
- → LDC's provided two burner stove to each household.
- Once the connection fees are paid, commodity cost won't reach US\$ 2/month.

Social Programs by Fundación Promigas

- Creation and/or strengthen of 560 Famiempresas in Arenal and Ayapel (21 for woodcutters).
- Home economy training for 1,500 families.
- → Home economy training for 300 multiplying agents.
- Diffusion of educational messages for 100% of the families.
- Healthy Readers Program with 39 educational institutions. Training for 195 teachers and resources for 39 libraries.





## Natural Gas in Colombia: Connecting poor households

#### A Contribution to Sustainable Development and Poverty Reduction Experience

Operational Outputs



- Households connected: 34,142 (98% execution).
- Three monthly payments required.
- Funds donated were managed in US dollars. Exchange rate assumed by LDCs.
- Funds administered by GPOBA.

Users fees (Affordability)



- Connection Cost 2005 (average) US\$370.
- Subsidy per household 2005 US\$141.
- Percentage subsidized 38%.
- LDC's distributed a two burner stove to each household.
- Once the connection fees are paid, commodity cost won't reach US\$ 2/month.



## Natural Gas in Colombia: Connecting poor households

#### Research developed by Universidad de Cartagena:

**Main findings** 




Coverage of 7.8% of households with unmet basic needs.

Economic costs of burden disease are reduced in 32%, from a total cost that could reach US\$ 23 million.

For every dollar invested in subsidies, government saves a dollar in burden disease treatments (Five years pay back period).




## Natural Gas in Colombia: Connecting poor households

#### A Contribution to Sustainable Development and Poverty Reduction Experience

- IFC, former Promigas shareholder, advised about the existence of GPOBA projects.
- Promigas approached GPOBA on December 2005 and supported a proposal to develop a new subsidy project.
- Once approved, the project started in June 2006 and ended in 2008.
- GPOBA donation: US\$5,000,000.

#### Project's Objectives



- Complement or reduce users' fees.
- Improve affordability to natural gas service.
- Contribute to a sustainable development and poverty reduction.



# Natural Gas Impact: in health and social development

#### In campus research carried out by Universidad del Norte, Main findings:

Households with children with respiratory problems	36,5%	26,8%	12,6%
Households with teens with respiratory problems	12,2%	6,5%	4,6%
Households with adults with respiratory problems	23,1%	13,9%	9,5%

Households with hospitalized members due to respiratory problems	74	18	17
Average number of days hospitalized due to respiratory problems	705	194	102
Households' average expense on preparing meals (US\$)	\$ 9,40	\$ 3,79	\$ 3,62
Fuel expense vs household revenues	7,6%	2,2%	2,4%
Savings from changing fuels	5,6%	8,1%	13,7%

- → 79% of those polled expressed they had experienced improvement in life quality (increase on revenues, greater savings, sanitary environment).
- 84% of households observed a development in the community.
