EFFECT License Agreement

This document sets forth the terms on which International Bank for Reconstruction and Development and the International Development Association ("The World Bank") makes the EFFECT software platform (as defined below) available for use. By downloading, storing, or using EFFECT, you agree to be bound by the following terms and conditions of use ("EFFECT License Agreement"). The term "you" refers to a user of EFFECT.

1. World Bank EFFECT

The Energy Forecasting Framework and Emissions Consensus Tool (EFFECT) is a software platform developed by the Energy Sector Management Assistance Program (ESMAP) of the World Bank for building low carbon development scenarios and forecasting their green house gas emissions.

EFFECT covers six sectors: Transport, Power, Industry, Households, Agriculture, and Non-Residential. It is an open and flexible tool which allows users to customize it for their particular needs in building low carbon development scenarios, bringing a wide range of stakeholders together, prioritizing investments, forecasting energy producing/consuming assets in a country, and forecasting GHG emissions. The World Bank releases subsequent versions of EFFECT and recommends licensees to register with us after installing the program so we can notify you about updates, features, and new releases of EFFECT. New versions may not be compatible with previous versions. Its performance critically depends on having most recent copies of the city data and recommendation sheets in EFFECT.

2. License to World Bank EFFECT & Data

The License grants you a world-wide, royalty-free, non-exclusive license to use, reproduce, distribute, or create derivative works, subject to the following restrictions:

You agree that you may not use, reproduce, or distribute EFFECT, for a fee charge or charge for derivative works based on it.

You agree not to use EFFECT in any way that is unlawful, or harms the World Bank, its service providers, its suppliers, your end users, or any other person.

You may modify, decompile, disassemble or reverse engineer any portion of EFFECT.

You may not use EFFECT in a manner that fails to comply or is inconsistent with any part of the EFFECT materials (User Manuals, Installation Instructions, and other documentation) located at http://esmap.org/esmap/EFFECT or supplied as part of EFFECT, as determined by the World Bank in its sole discretion.

4. World Bank Name and Logo

5. Limited Relationship

This License Agreement does not create an employer-employee relationship, a partnership, or a joint venture. While you may publicly refer to the fact that you have licensed EFFECT, you agree not to make any other public statements that assert or imply any other relationship with The World Bank.

6. Indemnity

You agree to hold harmless and indemnify the World Bank and its affiliates, its officers, agents, employees, and suppliers, from and against any third party claim arising from or in any way related to your use of EFFECT other than as set forth in this License Agreement, or other actions connected with use of EFFECT, including any liability or expense arising from all claims, losses,

damages (actual and consequential), suits, judgments, litigation costs and attorneys' fees, of every kind and nature. In such a case, the World Bank will provide you with written notice of such claim, suit or action.

7. No Warranty

The World Bank provides EFFECT "as is," "with all faults" and "as available," and the entire risk as to satisfactory quality, performance, accuracy, and effort is with you. To the maximum extent permitted by applicable law, the World Bank and its suppliers make no representations, warranties, or conditions, whether expressed or implied. The World Bank and its suppliers expressly disclaim any and all warranties or conditions, whether expressed, statutory, or implied, including without limitation: (a) warranties or conditions of merchantability, fitness for a particular purpose, accuracy, title, no encumbrances, no liens and non-infringement, (b) warranties or conditions arising through course of dealing or usage of trade, and (c) warranties or conditions of uninterrupted or error-free access or use.

8. Liability Limitation; Exclusive Remedy

The exclusion of damages under this paragraph is independent of your exclusive remedy and survives in the event such remedy fails of its essential purpose or is otherwise deemed unenforceable.
